I undertake **not to sell** or use the vehicle for hire or any other commercial purpose, or **to lend** it to any other person in any of these countries. **I will export it from each country within the terms of availability of the A.I.T / F.I.A Insured Carnet supplied and comply with the Customs regulations in each country.**

I further undertake to deliver the A.I.T / F.I.A Insured Carnet **by hand or registered post** to the Automobile Association of Malaysia, duly signed and stamped by the Customs of every Country, which **the cars has entered and left under cover of the Carnet, within 12 months from the date of issue of the said Carnet.**

In the event of serious damage to the vehicle, or its destruction by fire or other accident whatsoever, I will arrange for the vehicle or the salvage therefrom to be placed in safe custody and will immediately after the occurrence, or in the event of loss through theft, notify the nearest Police Station, the guaranteeing Association in the country where the accident took place, and the Automobile Association of Malaysia and give both Associations full particulars of the circumstances.

I grant the Automobile Association of Malaysia the right to repatriate my vehicle to the States of Malaya or other country or registration, **at my expense** if such action becomes necessary in order to avoid the imposition of Customs Charges.

I agree to indemnify the A.A Malaysia respectively its insurers against all payments it may be called upon to meet by reason of its guarantee in respect of the car, **a true description of which is given** overleaf and as security, **I agree to furnish a Bank Guarantee** in respect of such indemnification, or to **deposit with the Association such sum in cash as they may require.**

I, the holder of the insured Carnet, pledge myself to remain pecuniarily and personally responsible for any damage resulting from wrong information on the use, description, weight or value of the vehicle, surcharges, erasures on the Insured Carnet, or misuse of that document.

If through any cause whatsoever the amount deposited and / or guaranteed be hereafter rendered insufficient to meet the contingent claims of the Association, I undertake to increase the sum deposited or guaranteed to the full amount required by the Association. **No evidence of the Association's liabilities will be required beyond a request addressed to me in writing by the Secretary of the Association.**

I further authorise the Automobile Association of Malaysia to apply to the Passport Office, Customs Office, Military Authority, or any other sch Authority having the power to do so, to disclose my last known address and forwarding address, if known to them if so required in connection with the issue of the A.I.T / F.I.A Insured Customs Carnet granted to me. I also undertake if required to do so by the Automobile Association of Malaysia to deposit a letter signed by me authorising the above offices or Authorities to disclose the above information to the Automobile Association of Malaysia.
